

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.martinterry.org, and Martin Terry Art and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Martin Terry Art include www.martinterry.org. The Martin Terry Art website is a Artist Portfolio and Commerce site. By using the Martin Terry Art website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Martin Terry Art may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Martin Terry Art's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Martin Terry Art collects and uses your personal information to operate and deliver the services you have requested.

Martin Terry Art may also use your personally identifiable information to inform you of other products or services available from Martin Terry Art and its affiliates.

Sharing Information with Third Parties

Martin Terry Art does not sell, rent or lease its customer lists to third parties.

Martin Terry Art may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Martin Terry Art, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Martin Terry Art. Use of Cookies
